of me Nathaniel Barling in the parish of St Andrew in the Isle of Wight
 in the County of Kent Gentleman being of sound and disposing mind and memory
 this 16 day of August one thousand eight hundred and thirty one first direct
 that my body may be decently interred and buried by and at the discretion of
 of my Executors hereinafter named and that all my just debts be paid and
 all expenses in consequence in administering to my will I affect an Assurance
 in the Atlas Assurance Company, Liverpool London for three hundred pounds a
 payable at my death with all my household furniture silver plate and
 books &c &c &c &c &c &c &c I do bequeath all I am now or may be pos-
 sessed of at my death to my ten Children to be equally divided among them all
 share and share alike that is to say my Sons Nathaniel Barling William
 Barling Henry Barling Edward Barling Jeremiah Barling and my daughters
 Ann William Plotter Susan Walter Francis Cover & Thomas George Obry
 my Executors hereinafter named with the proviso and declaration and an au-
 thority hereinafter given and expressed concerning the same that is to say of
 Mr. Francis Plotter dies before me the Testator I do will and bequeath that the
 share that would have come to her viz one tenth part of my property shall be
 equally divided amongst the remainder of my Sons and daughters share and share
 alike & provided I will that if any other of my Sons and daughters depart a
 this life before they receive their part or share shall go to their Child or in
 Children to share and share alike and lastly I do hereby make nominate con-
 stitute and appoint Mr. John Hills Esquire of the County of Kent in the
 County of Kent my joint Executor of this my last will and Testament
 and I do make public and declare this is and for and only to be & contain
 my last will and Testament & I witness whereof I the said Nathaniel Barling
 the Testator have set my hand and seal the day and year before written =

 and appurtenances to the same belonging unto my dear wife Elizabeth Blaker her a
 heirs executors administrators assigns and assigns to hold the said freehold in a
 usufruct or tenement during her life and residue of my said personal estate
 and effects and premises and every part thereof with their and every of their in
 rights members & appurtenances to the only proper use and behoof of my said
