 of our Lord one thousand seven hundred and twenty
 four William Bradley Esq. signed and sealed

 published and declared as and for his last Will and
 Testament in the presence of us who have hereunto
 subscribed our Names as Witnesses to write in his
 presence and at his Request - John Bellwood
 James Taylor

and reading all

 my last Will and
 Testament

This Will was proved at London on the
 fourth day of April in the year of our Lord one
 thousand eight hundred and ten before the Right
 Honourable Sir John Dribbell Knight Justice of
 Law Master Keeper or Commissary of the prerogative
 Court of Canterbury lawfully constituted by the Oath
 of the Mary Bradley Widow the Relict and sole
 executrix named in the said Will to whom Administration
 was granted of all and singular the Goods Chattels
 and Credits of the deceased after having been first
 sworn by Commission duly to administer

This is the last Will, Katherine
 and Testament of me Katherine Blaker of Bridgeton
 in the County of Sussex spinster first single and single
 that all my just debts and funeral expenses be paid
 and discharged by my Executor and executrix herein
 after named of give and bequeath to my sister Anna
 Skipping the Wife of Henry Skipping of Bridgeton
 aforesaid surgeon and Apothecary all and every my
 wearing apparel plate Rings and paraphernalia
 to be had and taken by her immediately after my
 decease and all the rest residue and remainder of
 my Estate Goods Chattels Money and Effects I give
 and bequeath to Nicholas Willard of Eastham in
 the said County Gentleman and Thomas Kemp
 of Lewes in the said County Gentleman their
 Executors and Administrators in Trust and to and
 for the several uses intents and purposes therein
 after mentioned (that is to say) in Trust as soon as
 conveniently may be after my decease to lay out and
 invest the same in and upon Government Securities or
 some other good and sufficient security or securities
 and from time to time to pay apply and dispose
 of the Dividends Interest or Profits thereof to such
 persons and in such manner as are hereinafter

next mentioned (that is to say) one Moiety or half
 part thereof to my Brother Nathaniel Blaker of Portland
 in the said County Kentman and the other Moiety or
 half part thereof to my said Sister Anna Shipping for
 and during the term of their several and respective natural
 lives and from and after the decease of the said
 Nathaniel Blaker I do hereby direct my said
 Trustees to pay one Moiety or half part of the
 Residue of my Estate and all Dividends and Interest
 and Profits which shall be then due for or in respect
 of the same unto and equally between and amongst
 all and every the Children of the said Nathaniel
 Blaker which shall be living at the time of his
 decease if more than one and if there shall be but
 one Child living then ^{to pay} the whole of such Moiety or
 Dividends Interest and Profits to and only Child
 And in Case the said Nathaniel Blaker shall leave
 no Child then I give and bequeath the said Moiety
 Dividends Interest and Profits unto and equally
 between and amongst all and every the Children of
 my said Sister Anna Shipping which shall be living
 at the time of the decease of the said Nathaniel
 Blaker if there shall be more than one and if there
 shall be but one Child then I give such Moiety
 Dividends Interest and Profits unto and only Child
 to be paid to such Children or only Child of the said
 Anna Shipping immediately after the decease of the
 said Nathaniel Blaker and I give and bequeath the same
 as to the other and every part thereof and all the Dividends
 Interest and Profits which shall be then due for
 or in respect of the said last mentioned Moiety unto
 and equally between and amongst all and every
 the Children of my said Sister Anna Shipping which
 shall be living at the time of his decease if
 there shall be more than one and if there shall
 be but one Child then living in such Case
 I give such last mentioned Moiety Dividends
 Interest and Profits unto and only Child to be
 paid unto such Children or only Child immediately
 after the decease of the said Anna Shipping And in
 Case the said Anna Shipping shall leave no Child
 living at the time of her decease then I do
 hereby direct my said Trustees to pay and apply
 the Interest Dividends and Profits of the said last
 mentioned Moiety from time to time to the said
 Anna Shipping for and during the term of her
 natural life and from and after the decease of
 the said Anna Shipping I give and bequeath the
 said last mentioned Moiety and the Dividends Interest
 and Profits which shall be then due thereon unto
 and equally between and amongst all and every the
 Children of the said Nathaniel Blaker which

Nathaniel Blaker said Anna Shipping I give and bequeath the same
 as to the other and every part thereof and all the Dividends
 Interest and Profits which shall be then due for
 or in respect of the said last mentioned Moiety unto
 and equally between and amongst all and every
 the Children of my said Sister Anna Shipping which
 shall be living at the time of his decease if
 there shall be more than one and if there shall
 be but one Child then living in such Case
 I give such last mentioned Moiety Dividends
 Interest and Profits unto and only Child to be
 paid unto such Children or only Child immediately
 after the decease of the said Anna Shipping And in
 Case the said Anna Shipping shall leave no Child
 living at the time of her decease then I do
 hereby direct my said Trustees to pay and apply
 the Interest Dividends and Profits of the said last
 mentioned Moiety from time to time to the said
 Anna Shipping for and during the term of her
 natural life and from and after the decease of
 the said Anna Shipping I give and bequeath the
 said last mentioned Moiety and the Dividends Interest
 and Profits which shall be then due thereon unto
 and equally between and amongst all and every the
 Children of the said Nathaniel Blaker which

shall be living at the time of the decease of the
 said Anna Shipping if there shall be more than one
 and if there shall be but one such Child then living
 I give such last mentioned Moiety Dividends Interest
 and profits unto such only Child to be paid to such
 Child or only Child immediately after the decease
 of the said Anna Shipping and in case it shall
 happen that either of them the said Nathaniel
 Blaker and Anna Shipping shall die without leaving
 any Child or Children living at the time of their
 respective death and the survivor of them shall
 in such case give and bequeath the whole of her
 Residue of my Estate unto such survivor and to be
 paid to him or her respectively as follows (to wit)
 in case the said Nathaniel Blaker shall survive
 the said Anna Shipping then the Moiety of the
 Residue of my Estate of which the said Nathaniel
 Blaker will by Virtue thereof be entitled to receive
 the Dividends Interest and profits for his life
 as aforesaid shall be paid to him with all Dividends
 Interest and profits then due immediately after the
 decease of the said Anna Shipping and the other
 Moiety thereof with all Dividends Interest and
 profits then due for or in respect of the said Anna
 Shipping and in case the said Anna Shipping
 shall survive and outlive the said Nathaniel
 Blaker then the whole of the Residue of my Estate
 and all Dividends Interest and profits then due
 for the same shall be paid to the said Anna
 Shipping immediately after the decease of the said
 Nathaniel Blaker and I do hereby give my said
 Trustees full power and Authority after the Residue
 of my Estate shall have been by them laid out
 and invested on Annuities or Securities as aforesaid
 at their discretion to call or take in the same or
 any part thereof and also to lay out and invest
 the same or any part thereof in any other stock
 or fund or in or upon any such other Annuity or
 Securities as shall be approved of by my said
 Trustees and so from time to time as often as they
 shall think it necessary or expedient for the
 Benefit of my Estate provided always and it is
 my will and meaning and I do hereby so declare
 that neither of my said Trustees shall be
 answerable or accountable for the care of these
 for the said Lands Receipts Payments or Defaults
 of the other of them but each of them for himself
 only and only for his respective Lands Receipts
 Payments or Defaults and that each of them shall
 be answerable only for what he shall respectively

and actually receive and no more and shall not be
 answerable for the loss of any Monies that shall
 happen by any ways or means whatsoever without
 his or their wilful Neglect or default And that they
 my said Trustees shall and may deduct out of the
 aforesaid Trust Monies all such Costs Charges and
 Damages and Expenses as they or either of them
 shall sustain be at or put unto in the Execution or
 Management of the said Trusts and Obligations &c
 And I do hereby constitute and appoint my said
 Brother and Sister Nathaniel Baker and Anna a
 Shipping joint Executor and Executrix of this my
 Will and lastly I make all former Wills by me
 made In witness whereof I the said Katherine
 Baker the Testatrix to this my last Will and
 Testament contained in three sheets of Paper have
 set my hand to each of the first two sheets thereof
 and my hand and seal to the third and last sheet
 the nineteenth day of April in the fourth
 year of the reign of our Sovereign Lord George the
 third by the Grace of God of Great Britain France
 and Ireland King Defender of the Faith and so forth
 the year of our Lord one thousand seven
 hundred and seventy six Katherine Baker
 Signed sealed published and declared by the said
 Katherine Baker the Testatrix as and for her last
 Will and Testament in the presence of us who in
 her presence at her request and in the presence of
 each other have subscribed our Names as Witnesses
 Charles Elliot Wm. Purcell

This Will was proved at London on the
 fourth day of April in the year of our Lord one
 thousand eight hundred and seven before the Right
 Honourable Sir John Dribble Knight Doctor of Laws
 Master of Requests or Comptroller of the prerogative Court
 of Cambridge lawfully constituted by the Oaths of
 Nathaniel Baker the Brother and Anna Shipping
 Widow the Executors named in the said Will to us
 whom Administration was granted of all and in
 singular the Goods Chattels and Credits of the said
 deceased they having been first (by Commission)
 duly to administer
